Last month, a U.S. judge ruled Mississippi's ban on adoption for same-sex couples as unconstitutional, therefore legalizing adoption for same-sex couples in all 50 states. This decision marked the biggest step in LGBTQ+ rights since the decision in June 2015 that legalized same-sex marriage in the country.

The decision was brought about by a lawsuit that was filed by four same-sex couples and the Campaign for Southern Equality against the Mississippi Department of Human Services. The lawsuit was filed in the U.S. District Court of the Southern District of Mississippi, and was presided over by U.S. Judge Daniel Jordan. At the end of the court proceedings, Jordan declared that Mississippi's ban on same-sex adoption was unconstitutional, and ordered the Mississippi Department of Human Services to stop enforcing the ban.

Before his ruling, Jordan cited the decision that legalized same-sex marriage, stating that allowing gay couples to marry also bestows upon them additional benefits, such as the right

to adopt children. In addition, Jordan argued that Mississippi's ban on same-sex adoption, which was first enforced in 2000, violates the "equal protection" clause in the Constitution, therefore making the ban unconstitutional.

Prior to this, adoption for same-sex couples was only legal in certain states, with many other states, particularly in Southern states, that ban it completely or make the process extremely difficult. However, with this decision, same-sex couples should now have rights to adopt children, just like their heterosexual counterparts. Considering the resistance the community has received from religious groups, this decision was a big victory.

Though the LGBTQ+ community is becoming more accepted by the American public, it still faces opposition from hateful religious groups, who have been particularly vocal since the ruling. The LGBTQ+ community pushes on, refusing to give up and winning back their human rights.



The fight to adopt children was a long and hard battle for the LGBTQ+ community but ended in a major success.

Fear and Loathing in Panama

On April 3, 2016, The International Consortium of Investigative Journalists released a gigantic leak of almost 11 million documents scanning the past four decades, apparently connected to Panamanian law firm Mossack Fonseca. The Consortium reports that the said firm helped to established secret shell companies and offshore accounts for important global figures. The recent 2015 audit discovered that Mossack Fonseca knew the

true identities of--how many?--a stunning mere 204 of 14,086 companies.

The documents were given to the Consortium by Germany's Suddeutsche Zeitung, who received them from an anonymous source. The source "claimed to be concerned about what he or she saw in the documents. Of course, the documents started as a trickle but turned into a flood, a torrent in the end," says Gerard Ryle, the director of

Not only were Russian President Vladimir Putin, the FIFA ethics committee, and men that the United States government involved, but the leaders and former world leaders of 12 countries, as well as 128 other politicians and public officials. These documents accuse the prime minister of Iceland, Sigmundur David Gunnlaugsson, of having ties, through his wife, to an offshore company that were not properly disclosed.

While the Kremlin immediately dismissed the allegations as "a series of fibs" aimed at discrediting Putin shortly before his elections and Icelandic prime minister's office reported that the Icelandic prime minister had never owned a stake in a firm he was not linked to, and enjoyed no tax advantages, Britain, France, Australia and Mexico have vowed to conduct investigations for possible tax evasion.


